## Tribal Event Liability Release and Photography Release

IN CONSIDERATION for being allowed to participate in the Event, I agree to assume all risks permitted by law and agree for myself and on behalf of my heirs, guardians, representatives, successors and assigns (collectively, "myself") to make no claim, demand or sue the Eastern Band of Cherokee Indians or its affiliated entities, organizations, employees, agents, officers, directors, promoters, licensees, successors or assigns (collectively, the "Tribe"), for any injury, damages, or death resulting from negligence or any other cause, due to my participation in the Event.

I release the Tribe from all liability, actions, claims, suits, and demands for myself and on behalf of my heirs, guardians, representatives, successors and assigns, that may exist for any injury, damages, or death whether from negligence or another cause I may suffer due to my participation in the Event.

I give my permission to the Tribe the right to take, use, reproduce, edit, photograph, record, broadcast and otherwise exploit in any and all media, in whole or in part, including for commercial promotion of the Tribe and Event, my and/or my minor child(ren) or ward's image, likeness, voice, name and biographical information in connection with the Event and release the Tribe from all claims, demands, suits and liability that I or my successors and assigns may have for such use.
